Welcome to C&W's first Parish Council newsletter which we are trialling as part of an initiative to improve communication with village residents (see 2- way communication below). Improving 2 Way Communication

The Council is constantly discussing ways in which the flow of communication about village matters can be improved either through printed media (e.g. In Touch) or through our website and social media. The best way of keeping up to date currently is to follow our Facebook page which is continually updated with posts on matters which affect the village. Minutes from formal meetings continue to be posted on notice boards outside the Church Room and opposite the Village Hall.

Recognising that Council meeting protocols often prevent open discussion with residents, we will also be piloting face to face surgeries before each Parish Council meeting during which anyone can come and raise / discuss an issue they are concerned about directly with a Parish Councillor. BROCKLEY WOOD

Residents will be aware of the application to create a 90 acre sand & gravel pit and waste management site at Brockley Wood just outside our Parish boundary. The Council is vehemently opposed to this development on environmental and road safety grounds and was due to speak at the Planning meeting held in December. The application was temporarily withdrawn just before the meeting but has now been reissued for further consultation, this time without the concrete batching element of the proposal. Residents can comment further by visiting suffolk.planning-register.co.uk, deadline 11th February.

We will continue to keep residents advised of developments, but any immediate questions should be addressed to our Clerk (see contact details left).

ONE OR TWO REFURBS

WATCH YOUR SPEED!

The Council is aware of resident's concerns about the speed of traffic through the village and is considering ways of managing this more effectively, including the possible establishment of a Community Speedwatch scheme and installation of a "smiley face" Speed Indicator Device.

BMSDC Joint Local Plan

Residents will be aware that BMSDC have now started work on redeveloping their 2018-2037 Joint Local Plan following the Government Inspector's approval of their proposed changes. This will include a significant scaling back of new housing numbers from the original plan that was rejected in 2022. Our own Neighbourhood Pan – which does not recommend any sites for development – will be put before residents in a referendum, hopefully in the first half of this year.
